

MARCH 9, 2017

TOWN BOARD MEETING

The regular monthly meeting of the Board of Trustees of Caseyville Township was called to order at 7 p.m. by Supervisor Canty who directed Clerk Jacknewitz to call the roll, and upon roll call the following members answered present: Trustees Chrismore, Lemansky, and Donovan: absent Moody. Also present John Waldron, highway commissioner, Joe Steinhauer, security, Mark Blackburn, Pat Baeske, Montica Casey-Watt, Randy Pierce, Linda Hoppe, and Justin Renner.

Supervisor Canty directed Clerk Jacknewitz to read the minutes of the previous meeting. A motion was made by Mr. Lemansky, second by Mr. Donovan to dispense with the reading of the minutes, and motion carried.

The following bills were approved for payment upon a motion by Mr. Donovan, second by Mr. Lemansky, and motion carried. Bills totaled as follows:

A motion was made by Mr. Chrismore, second by Mr. Lemansky to divide the approved IPRF Safety & Educational Grant Award in the amount of \$1,982.00 to the road district and the sewer system. Motion carried.

A motion was made by Mr. Donovan, second by Mr. Lemansky to place a letter from Eric Mooshegian, Business Representative, Local 148 Operating Engineers concerning a union employee contractual wage increase and employee union dues increase on file. Motion carried.

A motion was made by Mr. Lemansky, second by Mr. Chrismore to place a letter from Eric Mooshegian, Business Representative, Local 148 Operating Engineers concerning the Union Collective Bargaining Agreement that expires midnight May 1, 2017 on file. Motion carried.

A motion was made by Mr. Lemansky, second by Mr. Chrismore to place a letter from Tom Tyler, Executive Director, Metro-East Regional Chamber of Commerce concerning the 2017 membership renewal notice on file. Motion carried.

Highway Commissioner Waldron came before the Board to discuss the following information:

The road crew has completed the winter maintenance.

The road crew has been sweeping the township roads.


The road crew has been repairing culverts.
