

The regular monthly meeting of the Board of Trustees of Caseyville Township was called to order at 7 p.m. by Supervisor Donovan who directed Clerk Jacknewitz to call the roll, and upon roll call the following members answered present: Trustees Lemansky, Gough, Green, and Wilson. Also present John Waldron, highway commissioner, Joe Steinhauer, security, Todd Fleming, sewer system operations attorney, Tim Fleming, attorney, Doug Bridges, agent, Salvage & Bridges Insurance Agency.

Supervisor Donovan directed Clerk Jacknewitz to read the minutes of the previous meeting. A motion was made by Mr. Green, second by Mr. Lemansky to dispense with the reading of the minutes, and motion carried.

A motion was made Mr. Gough, second by Mr. Green to approve the minutes of the previous meeting with the following roll call vote: Lemansky – aye, Gough – aye, Green – aye, Wilson – aye, and Donovan – aye. Motion carried by a vote of 5 ayes, and 0 nays.

The following bills were approved for payment upon a motion by Mr. Wilson, second by Mr. Gough with the following roll call vote: Lemansky – aye, Gough – aye, Green – aye, Wilson – aye, and Donovan – aye. Motion carried by a vote of 5 ayes, and 0 nays.

Supervisor Donovan informed the Board that an updated General Assistance Handbook containing rules and regulations will be adopted by the Supervisor as of November 9, 2017.

Supervisor Donovan informed the Board the Illinois Public Risk Fund reimbursed Caseyville Township for workers compensation overpayment in the amount of \$2,165.00.

Doug Bridges, agent, Salvage & Bridges came before the Board to discuss liability, workers comp, crime policy, property, and unemployment insurance for Caseyville Township.

A motion was made by Mr. Gough, second by Mr. Green to renew the discussed insurance for Caseyville Township with the following roll call vote: Lemansky – aye, Gough – aye, Green – aye, Wilson – aye, and Donovan – aye. Motion carried by a vote of 5 ayes, and 0 nays.

Highway Commissioner Waldron came before the Board to discuss the following information:

The road crew replaced several culverts.

The road crew has been cleaning culverts and sweeping streets.

The road crew is doing winter maintenance at the road district property.

The large item pickup for the Caseyville Township unincorporated area was conducted on Monday, November 6, 2017.

There being no further business to come before the Board, a motion to adjourn was made by Mr. Gough, second by Mr. Green, and motion carried.
