TOWN BOARD MEETING

The regular monthly meeting of the Board of Trustees of Caseyville Township was called to order at 7 p.m. by Supervisor Donovan who directed Clerk Jacknewitz to call the roll, and upon roll call the following members answered present: Trustees Lemansky, Gough, and Green. Also present John Waldron, highway commissioner, Joe Steinhauer, security, Todd Fleming, sewer system operations attorney, Wally Abernathy, Kevin Kaufhold, John Buckley, Sheila Berry, Dalton Berry, G W Scott Sr., G W Scott Jr., and Kristin Scott.

Supervisor Donovan directed Clerk Jacknewitz to read the minutes of the previous meeting. A motion was made by Mr. Green, second by Mr. Lemansky to dispense with the reading of the minutes with the following roll call vote: Lemansky – aye, Gough – aye, Green – aye, and Donovan – aye. Motion carried by a vote of 4 ayes, and 0 nays.

The road crew has been cleaning and installing culverts this week.

Discussed roadway drainage issues.
