Corona Virus 19 Update: The Sewer System is running well, and we are at 100% staff.

The Sewer System has narrowed the number of 29 trees to be taken down for the West Plant Tree Trimming and Removal Project. A Sewer System employee will take down the rest.

New Business - Sewer 11

The Board discussed and approved sending two employees to the Wastewater Technical Conference in Effingham IL. The cost to send two employees for a two day conference is \$480.00 and one night hotel reimbursement. Motion carried unanimously.

The new zero turn mower was delivered last week.

The Board discussed a sewer back up occurring at 104 and 106 Primrose Lane, Fairview Heights The cause of the back up was grease in the sewer line, there was some damage done to the properties and this has been turned in to the insurance company.

The Board is starting a discussion concerning sewer rate increases for the 2023 fiscal year. The Sewer System has not had a rate increase in twelve years.

There being no further business to come before the Board, a motion to adjourn was made by Ms. Scott, second by Mr. Green with the following roll call vote: Lowry – aye, Gibbs – aye, Scott – aye, Green – aye, and Krummrich – aye. Motion carried by a vote of 5 ayes, and 0 nays.
