Unfinished Business

Sewer Manger Bevirt spoke before the Board to discuss the Manhole Lining Project 2017-2019 and possible approval of Spectra-Tech's bid of \$260.00 per vertical foot of manhole for years 2017, 2018, and 2019. Cost for 2017 will be \$67,470.00.

A motion was made by Mr. Gough, second by Mr. Green to approve Spectra-Tech's bid of \$260.00 per vertical foot of manhole for 2017, 2018, and 2019 - cost for the year 2017 will be \$67,470.00 with the following roll call vote: Lemansky – aye, Gough – aye, Green – aye, Wilson – aye, and Donovan – aye. Motion carried by a vote of 5 ayes, and 0 nays.

Sewer Manager Bevirt said the West Washington gate project is proceeding as projected.
