The Pasadena Lift Station Replacement Project is almost complete. The crew finished the road this week, and are working on restoring the yard with new grass.

The 2020 Manhole Lining Project is complete, everything went well and thirty manholes were rehabbed this year.

The Caseyville Township Sewer System is still accepting applications for the new Sewer System Treatment Plant Operator position.

## Corona Virus Update:

The East Plant is open to the public, everything is going well, and we are still at full staff.

There being no further business to come before the Board, a motion to adjourn was made by Mr. Gough, second by Mr. Green with the following roll call vote: Lemansky – aye, Gough – aye, Green – aye, and Scott – aye. Motion carried by a vote of 4 ayes, 0 nays, and 1 absent.
