TOWN BOARD MEETING / ZOOM CONFERENCE

The regular monthly meeting of the Board of Trustees of Caseyville Township was called to order at 5:30 p.m. by Supervisor Krummrich who directed Clerk Gough to call the roll, and upon roll call the following members answered present: Trustees Scott, Green and Gibbs; excused Lowry. Also present John Waldron, highway Commissioner, Todd Fleming, sewer system operations attorney, and Ken Sharkey, managing director, St. Clair County Transit District.

Supervisor Krummrich directed Clerk Gough to read the minutes of the previous meeting. A motion was made by Mr. Gibbs, second by Ms. Scott to dispense with the reading of the minutes with the following roll call vote: Scott – aye, Green – aye, Gibbs – aye, and Krummrich – aye. Motion carried by a vote of 4 ayes, 0 nays, 1 absent.

Highway Commissioner Waldron spoke before the Board with the following information: The road crew has been busy this week mowing along road easements, ditching roadways, vacuuming leaves, replacing old walls at the township road garage, getting the snow plows and spreaders ready for the upcoming snow season, replaced damaged road signs, also the Hunters Landing -Long Branch Lane Overlay Project is finished.


Large trash pick-up will be held on Monday, December 6, 2021.
