The purchase of land for sale located by the West Plant is complete.

The East Plant Paint Project is going out for bid on March 13, 2023, accept bids on April 6, 2023 and will award the bid on April 20, 2023.

The Board discussed the easement agreement for the new 36" sewer main.

Sewer Manager LePere presented before the Board information concerning a potential sewer rate increases for the 2023 fiscal year.
