Sewer Manager LePere spoke to the Board concerning the Sewer System would like to purchase their own man lift to be used for multiple jobs around the plant and collections system at the cost of \$70,000.00 for one man lift. The sewer system currently rents one as needed.

The Township Board discussed approving an IGD Grant Program for year 2023 to be used for the Homestead Crossroad Terrace East and Meadowbrook Garden Estates Subdivisions.

There being no further business to come before the Board, a motion to adjourn was made by Ms. Scott, second by Mr. Green with the following roll call vote: Green – aye, Scott – aye, Gibbs – aye, Lowry – aye, and Krummrich – aye. Motion carried by a vote of 5 ayes, and 0 nays.
