A motion was made by Mr. Green, second by Mr. Lowry to award the East Plant Paint Project to Brazan Painting Company in the amount of \$269,800.00 with the following roll call vote: Green – aye, Scott – aye, Lowry – aye, Krummrich – aye. Motion carried by a vote of 4 ayes, 0 nays, 1 absent.

The East Plant Lift Station Crane Project is going well, and just waiting on electric.

The easement agreement for the new 36" sewer main should be completed soon.

The preconstruction meeting was held on July 20, 2023 for the Ridge Prairie Heights Sewer Project.

The Jade prive Lift Station Piping Project has been awarded and the project should begin in the next couple of months.

The Longacre Lift Station easement project will be completed soon.

Discussed the 2023 Fiscal Year raises for the Sewer System Supervisors, Attorney and Sewer System Plant Manager. Board tabled the discussion.

New Business - Sewer

The Township Board is looking into financing a loan to fund the new 36' Sewer Main Project.
