Highway Commissioner Waldron spoke before the Board with the following information:

The road crew mowed along road easements.
Used the chipper for tree limbs.
Picked up trash on the road right of ways.
Cleaned and flushed culverts.
Removed weeds from the right of way guardrails.
Hauled rock for the upcoming road oiling.
Shop Maintenance.
Spread lime.
Pothole patching.
Replaced damaged culverts.

The next large trash pick-up will be held on Monday, October 7, 2024.

Clerk Gough spoke before the Board with the following information:
